



TALBOT FIGURE SKATING TEAM 2011-12 FAMILY VOLUNTEER POLICY & RELEASE

It takes a great amount of time and effort for the Talbot Figure Skating Team to be as successful as we are. Each team meeting requires several volunteers to ensure that the meeting runs smoothly.

To spread the amount of volunteer work equally, we require that during registration each parent sign up to help in one or more of the volunteer areas. If you are not sure which area you want to volunteer, you can sign up on the "miscellaneous" volunteer sheet and you will be contacted later about where we could use some help. The team requires 15 hours per family (10 for single parents) from the time they join through August 31st of the membership year. In addition, we require each parent to take part in a service for all of our Exhibitions as well as our Winter Home Ice Competition.

Being part of a successful figure skating season requires a commitment not only from your children but from the parents as well. By signing below, you agree to volunteer 15 hours (10 for single parents) in some capacity during the upcoming skating season as well as a part in our Fall and Spring Exhibitions and Winter Home Ice Competition.

- I agree to help make the 2011-12 Talbot Figure Skating Team season successful by serving as a volunteer during the upcoming season. **I'm attaching a Volunteer Deposit check (post dated for March 30, 2012) in the amount of \$150 (\$100 for single parents). This check must be separate from your membership check.** This check will be held and returned at the end of the season after all volunteer requirements have been met. If you do not volunteer at least 15 hours (10 for single parents), only a portion of the \$150 will be returned after deposit (\$10 per hour will be deducted). If you do not fulfill all of the volunteer requirements, your check will be deposited into the Talbot Figure Skating Team bank account no later than August 31, 2012.
